

Publicly owned speculative industrial building available on the Tennessee-Tombigbee Waterway, four-lane US Highway 72, and Norfolk Southern Railroad with rail spur under construction. Building expandable in two directions within an 800+ acre/324+ hectare industrial park. The building is designed for crane capacity of up to 40 tons/36 metric tons and the floors are 9 inch/23 cm reinforced concrete. Minimum ceiling clearance is 30'/9.1m. Two dock doors and one drive in door. Office space attached. Additional industrial park land is available, all in public ownership.

The Tennessee-Tombigbee Waterway connects to the Mississippi-Missouri-Ohio-Great Lakes-St. Lawrence Water Navigation System and the Gulf of Mexico at the Port of Mobile.
